Promotion:

Starts: 12.01 am AEST on 10 July 2026

Ends: 12.00 pm AEST on 30 September 2026

Eligible Entrants:

Entry is open to Australian residents aged 12 years or over, excluding:

- (a) directors, officers, management and employees of the Promoter;
- (b) any person directly involved in conducting the Promotion or determining the winners; and
- (c) any other person made ineligible under applicable law.

If an entrant is under 18 years of age, the entrant must have the prior consent of a parent or legal guardian to enter.

If a winner is under 18 years of age, the prize must be accepted on the winner's behalf by the winner's parent or legal guardian.

If a winner or guest is under 18 years of age at the time of the Tour Date, that person must be accompanied on the tour by a parent or legal guardian, or another responsible adult approved in writing by the Promoter.

How to Enter:

Cost of Entry:

Maximum Entries:

One (1) entry per person during the Promotional Period.

Prize:

- an experience in mine machinery; and
